## SUPPLEMENT TO CAUSE DESCRIPTION

A DESIGN CHANGE HAS BEEN INITIATED TO REPLACE THE SPRING ADJUSTMENT BOLTS WITH LONGER BOLTS IN ORDER TO RELIEVE THE SPRING TENSION ON THE LOWER DOORS, (RFC 12-1762).

THE DOORS WERE IMMEDIATELY READJUSTED WHEN THE PROBLEM WAS FOUND AND NO ACTION WAS REQUIRED BY TECHNICAL SPECIFICATIONS.
