UNPLANNED RADJOACTIVE GAS RELEASE Subject:

This PN is being issued due to increased public interest in these type of ever

At approximately noon on April 12, 1980 the licensee notified the Headquarters Duty Officer (Red Phone) that they were experiencing a sporadic unplanned but monitored radioactive gaseous release from the auxiliary building vent stack.

Investigations by the licensee determined the source of the release was due to opening of a pressure relief valve on a Unit-1 primary system drain tank. The level indication on the tank was indicating a lower level than actual thus continued pumping to the already full tank resulted in the periodic opening of the relief valve. The discharge of the relief valve is directed to the auxil: building sump which is vented to the auxiliary building vent stack.

Calculations by the licensee based on the stack monitor readings indicate that the maximum instantaneous release rate was 0.32 percent of the Technical Spec tion limit. (65000 microcuries per second) (isotopic content not determined)

The licensee plans to issue a news release.

The site senior resident inspector was notified by the licensee and was on si. to witness the major portion of the licensee's investigative and corrective a.
