By letter dated July 10, 2017 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17194A637), TN Americas, LLC, submitted an application to revise the model No. TN-RAM transport package Certificate of Compliance (CoC) 9233.

The staff performed an acceptance review of your application to determine if the application contains sufficient technical information in scope and depth to allow the staff to complete a detailed technical review. This letter acknowledges acceptance of your application.

The application appears to contain the information needed for our technical review. The staff established a schedule and estimated approximately 500 hours to complete its review. The schedule allows for staff to issue a request for additional information (RAI), if necessary, in February 2018 and a revised CoC in June 2018. This timeframe may be adjusted based on factors such as the need to issue RAIs and/or the applicant responding satisfactorily to RAIs. In general, no additional changes to the application should be submitted except for changes resulting from your response to an RAI.
