Pursuant to 10 CFR 50, Appendix E, Section V, please find enclosed the cancellation notices for American Electric Power Service Corporation (AEPSC) General Procedure 1.3 "AEP Emergency Response Organization Emergency Preparedness Procedure", General Procedure 1.4 "Activation and Operation of the Engineering Emergency Operations Facility (Columbus)", General Procedure 1.5 "Activation and Operation of the Emergency Operations Facility (EOF)", and General Procedure 1.7 "AEP Emergency Response Organization Training Program". These procedures and the applicability of General Procedure 15.1 "Noncompliance and Corrective Action" to AEPSC's participation in emergency response associated with the Donald C. Cook Nuclear Plant, have been superseded by the AEPSC Emergency Response Manual. Three copies of the AEPSC Emergency Response Manual have also been enclosed. Deletion of the above procedures and replacement with the Emergency Response Manual does not decrease the effectiveness of the Donald C. Cook Nuclear Plant Emergency Plan.

It should be noted that there are some discrepancies between the AEPSC Emergency Response Manual and the Donald C. Cook Emergency Plan. These discrepancies exist as the result of changes in position titles and emergency response organization that were not included in Revision 3 to the Plan. However, these discrepancies do not decrease the effectiveness of the Plan and the Plan will be updated in the annual revision.
