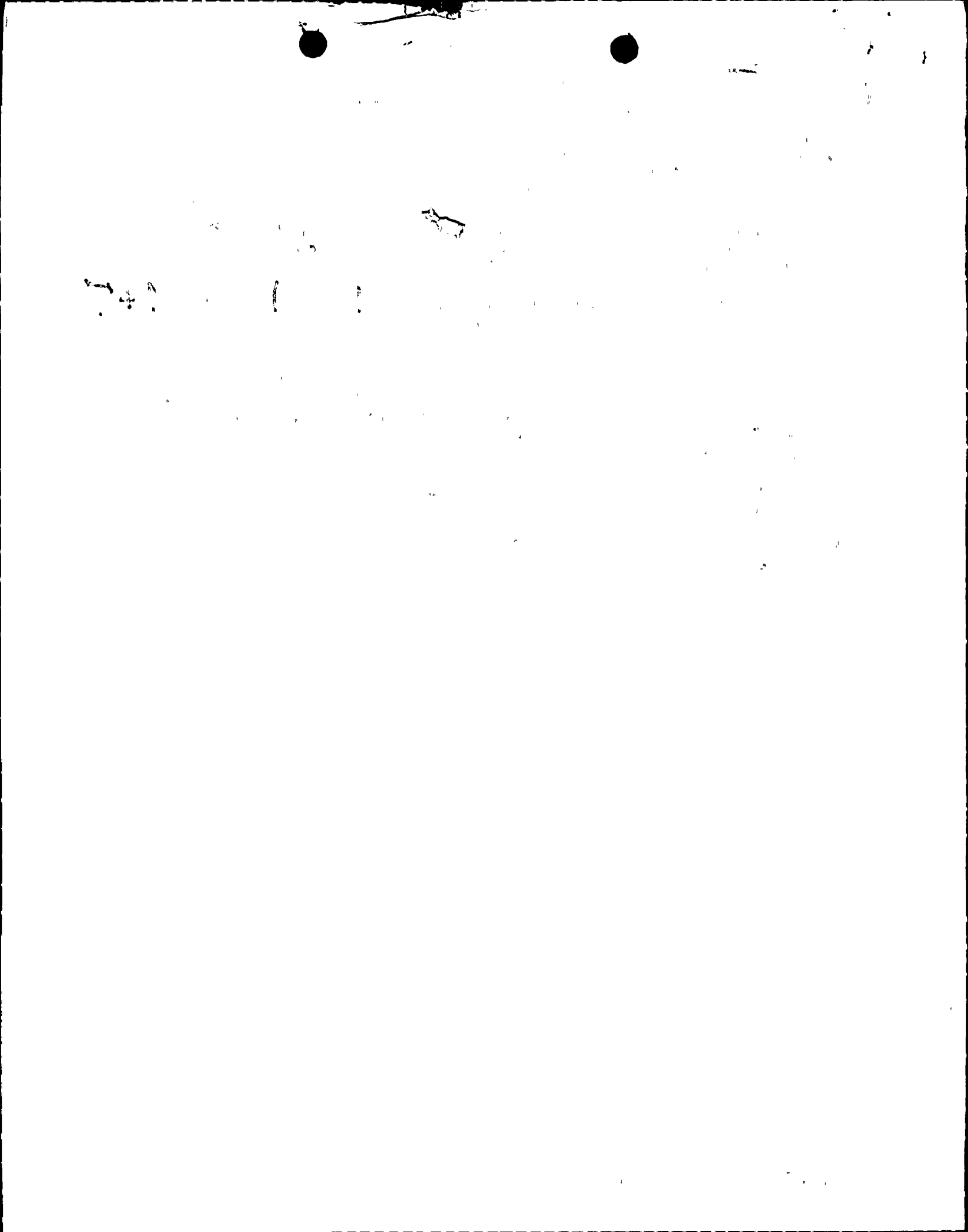


Dear Dr. Murley:
