This refers to the special safeguards inspection conducted by Mr. T. J. Madeda of this office on January 19-20, 1988, of activities at the D.C. Cook Nuclear Plant, Units 1 and 2 authorized by NRC Operating Licenses No. DPR-58 and No. DPR-74 and to the discussion of our findings with Mr. W. G. Smith, Jr. and other members of your staff at the conclusion of the inspection.

This information must be handled and protected in accordance with the provisions of 10 CFR 73.21. Consequently, the enclosure to this letter, our report of the inspection, and your response to the violation identified in the enclosure to this letter will not be placed in the NRC Public Document Room. Therefore, your statement of corrective action regarding the violation identified in the enclosure and your response to the concern noted in Section 5 of the enclosed report should be submitted as a separate enclosure to your transmittal letter in the manner prescribed.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
