The coverages provided on the Donald C. Cook Nuclear Plant for "All Risk" PROPERTY DAMAGE and DECONTAMINATION COVERAGE in the amount of \$1,725,000,000 subject to deductibles of \$1,000,000 per occurrence (Unit 1 Turbine) - \$1,089,000, (Unit 2 Turbine) - \$1,100,000 are as follows:

- \$363,500,000 portion of the first \$500,000,000 under American Nuclear Insurers Policy No. 5263.
- \$136,500,000 portion of the first \$500,000,000 under Mutual Atomic Energy Reinsurance Pool Policy No. TA 6010.
- \$240,000,000 as 48.0% of loss in excess of the first \$500,000,000 under American Nuclear Insurers Policy No. X89149.
- \$60,000,000 as 12.0% of loss in excess of the first \$500,000,000 under Mutual Atomic Energy Liability Underwriters Policy No. XTA 6170.
- \$86,000,000 as 17.2% of loss in excess of the first \$500,000,000 under American Nuclear Insurers Policy No. 5359S.
- \$14,000,000 as 2.8% of loss in excess of the first \$500,000,000 under Mutual Atomic Energy Liability Underwriters Policy No. TA 6171S.
- \$100,000,000 as 20.0% of loss in excess of the first \$500,000,000 under Nuclear Electric Insurance, Ltd. (NEIL II) Policy No. X88-019.
- \$725,000,000 as portion of loss in excess of the first \$500,000,000 under the above NEIL II Policy.
