This refers to your license amendment request dated September 27, 2017. Please find enclosed Amendment No. 15 authorizing an increase of possession from 20 to 30 millicuries per radionuclide for item 8.A. The acceptance of Financial Assurance will be provided under a separate cover.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
