This refers to the routine safety inspection conducted by B. L. Jorgensen and D. G. Passehl of this office on June 7 through July 18, 1989 of activities at the Donald C. Cook Nuclear Plant, Units 1 and 2 authorized by NRC Operating Licenses No. DPR-58 and DPR-74 and to the discussion of our findings with W. G. Smith, Jr., and others of your staff at the conclusion of the inspection.

This refers also to the special evaluation of a Unit 1 CD diesel overspeed event which was performed by Mr. E. Tomlinson of the NRC Office of Nuclear Reactor Regulation, and to the management meeting of June 22, 1989, which was held in NRC Region III and involved a presentation and discussion on several matters of mutual interest.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.
