Dear Dr. Murley:

This letter transmits the refinements requested by your staff on October 18, 1990, on our administrative controls technical specification (T/S) change request (AEP:NRC:0659M dated August 25, 1989, as modified by AEP:NRC:0659P dated December 12, 1989, and AEP:NRC:0659Q dated June 1, 1990). A brief description of the changes being made via this submittal is given below. The revised, proposed T/S pages are in the attachment to this letter. These pages supersede the corresponding pages contained in our submittal AEP:NRC:0659M as modified by our submittals AEP:NRC:0659P and 0659Q.

The following changes are being made to the attached T/S pages. Page numbers are for both units unless otherwise noted.

- o Page 6-1: Section 6.2.1.d has been corrected. It is now identical to the currently approved T/S.
- o Page 6-2: The words "hold or" have been added to Section 6.2.2.h, 6.3.1(3), and 6.5.1.2 to provide additional flexibility to the qualifications of the Operations Superintendent.
- o Page 6-4: The words "of a minimum" were deleted from Section 6.5.1.2 to more clearly define the number of members required for the PNSRC.



- o Page 6-6: Section 6.5.1.7 has been revised to require that the PNSRC render unreviewed safety question determinations in writing for items (a) through (c) and (e) of T/S 6.5.1.6. Our submittal AEP:NRC:0659M only required such determinations in writing for items (a) through (c).
- o Page 6-8: Section 6.5.2.7.a has been revised. It is now identical to the currently approved T/Ss.
- o Page 6-11: The word "approved" has been changed to "conducted" in Section 6.5.3.1.d.
- o Page 3/4 4-21 (Unit 1), 3/4 4-20 (Unit 2): These pages should be deleted from our AEP:NRC:0659M request due to the issuance of Amendments 142 and 129 for Units 1 and 2, respectively.
