Cook Nuclear Power Plant, Unit 1, State of Michigan, Number M-09672-M, located in Bridgman, Michigan. The Plant is owned by Indiana Michigan Power Company, One Summit Square, Ft. Wayne, Indiana 46802.

The unit's commercial service date is August 23, 1975 and has a gross generating capacity of 1080 MWe.
