The U. S. Nuclear Regulatory Commission (the Commission) has issued Amendment No. <sup>37</sup> to Facility Operating License No. DPR-58, and Amendment No. <sup>20</sup> to Facility Operating License No. DPR-74 issued to Indiana and Michigan Electric Company (the licensee), which revised Technical Specifications for operation of Donald C. Cook Nuclear Plant, Unit Nos. 1 and 2 (the facilities) located in Berrien County, Michigan. The amendments are effective as of the date of issuance.

The amendments (1) provide for a one time only extension of the time for testing the Unit No. 2 ice condenser lower inlet doors and (2) revises the withdrawal schedule for the reactor vessel surveillance capsules for Unit Nos. 1 and 2.

The application for the amendments complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations. The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR Chapter I, which are set forth in the license amendments. Prior public notice of these amendments was not required since the amendments do not involve a significant hazards consideration.



B. Scharf (10) The Commission has issued the enclosed Amendment No. 19 to Facility Operating License No. DPR-74 for the Donald C. Cook Nuclear Plant, Unit No. 2. The amendment consists of changes to the Technical Specifications in response to your application transmitted by letter dated November 2, 1979 as supplemented by letters dated December 11, 1979 and March 18, 1980. The amendments also delete license conditions which have been satisfied.

These amendments revise the maximum  $T_{avg}$  at Rated Thermal Power used for the overtemperature and overpower delta T trips and departing from . nucleate boiling (DNB) limits. The deletion of the license conditions recognize the modifications for leak testing certain containment isolation valves and installation of qualified 600 volt containment power penetration circuits.

Copies of the Safety Evaluation and the Notice of Issuance are also enclosed.
