Dear Mr. Gieck:

On October 5, 2107, the U.S. Nuclear Regulatory Commission (NRC) amended Umetco Minerals Corporation's (Umetco's) radioactive materials license for Umetco's Gas Hills, Wyoming site, through License Amendment 75, to reflect the 2017 financial surety update for the Gas Hills site (Agencywide Documents Access and Management System (ADAMS) Package Accession Number ML17234A549). On November 8, 2017, you informed the NRC staff of an error in the License Amendment, specifically, that the License Amendment included language in License Condition 35 that had been amended by a previous License Amendment, License Amendment 74. The NRC staff has reviewed License Condition 35 in the two amendments and has determined that License Condition 35 in License Amendment 75 is incorrect. License Condition 35 has been corrected, and the corrected license is enclosed.

An environmental assessment was not performed for this action as it is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Part 51.22(c)(10)(i).
