This refers to your license amendment request dated October 12, 2017. Please find enclosed Amendment No. 49, accepting the notification that the transfer of control of the Ohio Valley Medical Center to Alecto Healthcare Services Wheeling LLC occurred on June 1, 2017, and that the transfer of the license and materials subject to the license occurred on August 8, 2017. This amendment also removes License Condition 17.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
