This refers to your license amendment request dated October 10, 2017. Please find enclosed Amendment No. 3 listing Dr. Philipose G. Mulugeta as an authorized user. Please note that based on my October 30, 2017, phone conversation with Mike Ofori-Darkwa, stating that you will only use unit doses of Ga-68, no change was made to your license with respect to your request to add Ga-68 as this is covered under your authorization for 10 CFR 35.200 materials.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. 
