Please find enclosed Amendment No. 30 to NRC License No. 53-18126-01 removing authorization for Yttrium-90 permitted by 35.1000 use and deleting authorized users, as requested. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(10)(v) and (14)(iv). Note that your license and license conditions have been updated in a new format. Please review your license and notify this office if you have any discrepancies or questions.
