The lists of personnel who would fill certain key and support positions in the emergency organization were either enlarged, revised or clarified. Adequate references were made to revisions in the Environmental Protection Agency's Protective Action Guides and 10 CFR Part 20. Updated information was provided on the organization responsible for conducting periodic audits of the emergency preparedness program. Revision 13 also included several corrections and editorial changes.
