Subject: Additional Information

Discussion: I contacted Mr. Lairmore to request additional information to support the licensee’s request to add authorized users to the license.

1. The licensee submitted form 313AUD for the three physicians but did not complete the section where it requests name of proposed authorized user and the state where the physician is licensed. I asked that the licensee complete the forms in entirety and resubmit.
2. One of the physicians submitted a board certification as a pathway to demonstrate training and experience. Although the board is recognized by the NRC, the certificate did not have “for physicians trained in the united states” on it as required. I informed Mr. Lairmore that if the licensee desired to add the physician, they would need to demonstrate training and experience.

Mr. Lairmore agreed to follow up with the licensee to get the additional information needed and submit it.
