A. As we discussed on 11/20/2017, I am confirming that I no longer wish to add Ali Abassi, PharmD, MD to my license as an authorized user.

B. Spectron mrc, LLC pharmacy's proposed authorized uses of Cu-64 include redistribution, compounding and dispensing pharmaceuticals that are approved to contain Cu-64, research and development of new radiopharmaceuticals that are to incorporate Cu-64 and to possess and store prepared products for the subsequent chance of a physician request for the product. The redistribution will be for Cu-64 solution, radiopharmaceuticals that use Cu-64 as the radionuclide, and investigational radiopharmaceuticals and/or preparations made using Cu-64.

Spectron mrc, LLC's pharmacy intends to use Cu-64 in the following processes:

1. In preparation of FDA approved kits that include the need to add Cu-64 in the compounding and/or preparation procedures. A couple of current examples include but are not limited to: Cu-64 DOTATATE and Cu-64 PSMA.
2. For filling a physician's order for a pharmaceutical that includes the addition of Cu-64.
3. For the delivery of the physician's orders of C-64 radiopharmaceuticals
4. In the development of new radiopharmaceuticals for either diagnostic or therapeutic uses. This work could be for a third party contract or for a local physician's IND or for internal development.
5. To sell and deliver the Cu-64 as a radiochemical to any party that is authorized to receive Cu-64 and has an interest in purchasing Cu-64. Such customer could be affiliated research facilities, other radiopharmacies, along with hospitals and Universities having a need for Cu-64.

3. For the delivery of the physician's orders of Ga-68 radiopharmaceuticals
4. In the development of new radiopharmaceuticals for diagnostic use. This work could be for a third party contract or for a local physician's IND or for internal development. Internal development could include Ga-68 MAA and/or microspheres for hepatobiliary assessment.
5. To sell and deliver the Ga-68 as a radiochemical to any party that is authorized to receive Ga-68 and has an interest in purchasing Ga-68. Such customer could be affiliated research facilities, other radiopharmacies, along with hospitals and Universities having a need for Ga-68.
