

NOTICE OF VIOLATION

Indiana Michigan Power Company
Donald C. Cook Nuclear Plant

Docket Nos. 50-315; 50-316
License Nos. DPR-58, DPR-74

During an NRC inspection completed on June 2, 1998, a violation of NRC requirements was identified. In accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," NUREG-1600, the violation is listed below:

Technical Specification 6.8.1.a requires, in part, that procedures be implemented for activities recommended in Regulatory Guide 1.33, Revision 2, Appendix A, February 1978.

Regulatory Guide 1.33, Revision 2, Appendix A, Paragraph 7.e(4), requires that contamination controls be covered by procedures.

Procedure PMI 6010, "Radiation Protection Plan," step 20.2, states, in part, that all plant personnel, including first-line supervisors are given the responsibility and authority to ensure that work involving radiological protection is performed correctly. Exhibit B of this procedure, "Responsibilities of Each Worker," requires, in part, that workers report the presence of treated or open wounds to radiation protection personnel prior to entry into a restricted area.

Contrary to the above, on January 4, 1998, a worker entered containment, a radiologically restricted area, with an open wound, without anyone notifying radiation protection personnel of the open wound.

This is a Severity Level IV violation (Supplement IV).

For this violation, the NRC has concluded that information regarding the reason for the violation, the corrective actions taken and planned to correct the violation and prevent recurrence and the date when full compliance was achieved is already adequately addressed on the docket in Inspection Report Nos. 50-315/98013(DRS) and 50-316/98013(DRS). However, you are required to submit a written statement of explanation pursuant to 10 CFR 2.201 if the description therein does not accurately reflect your corrective actions or your position. In that case, or if you choose to respond, clearly mark your response as a "Reply to a Notice of Violation," and send it to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, D.C. 20555 with a copy to the Regional Administrator, Region III, and a copy to the NRC Resident Inspector at the facility that is the subject of this Notice, within 30 days of the date of the letter transmitting this Notice of Violation (Notice).

If you contest this enforcement action, you should also provide a copy of your response to the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001.

Because your response will be placed in the NRC Public Document Room (PDR), to the extent possible, it should not include any personal privacy, proprietary, or safeguards information so that it can be placed in the PDR without redaction. If personal privacy or proprietary information is necessary to provide an acceptable response, then please provide a bracketed copy of your response that identifies the information that should be protected and a redacted copy of your response that deletes such information. If you request withholding of such material, you must

specifically identify the portions of your response that you seek to have withheld and provide in detail the bases for your claim of withholding (e.g., explain why the disclosure of information will create an unwarranted invasion of personal privacy or provide the information required by 10 CFR 2.790(b) to support a request for withholding confidential commercial or financial information). If safeguards information is necessary to provide an acceptable response, please provide the level of protection described in 10 CFR 73.21.
