

On April 17, 1998, with both Unit 1 and Unit 2 in Mode 5, an ENS notification (NRC Event # 34092) was made regarding the potential inaccuracy of ice condenser basket weights as the result of an allegation made by a concerned individual. A preliminary review of the ice weight data from the Unit 1 and Unit 2 1997 weight surveillances was performed after the allegation was received, and it was determined that a notification under 10CFR50.72(b)(2)(i) should be made. This allegation has been investigated, and the results of that investigation will be provided to the NRC in AEP:NRC:1287, which is expected to be issued by May 22, 1998. As the letter will contain all necessary information, this LER will be considered closed with the issuance of the letter.
