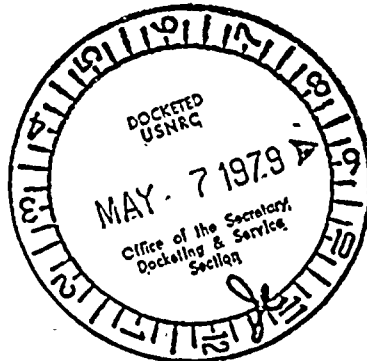
Dear Chairman Hendrie:
