SUBJECT: SUMMARY OF NOVEMBER 7, 2017, MEETING WITH NUCLEAR
ENERGY INSTITUTE (NEI) REGULATORY ISSUES TASK
FORCE (RITF)

On November 7, 2017, a Category 2 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of the NEI RITF at NRC Headquarters. The purpose of the meeting was to discuss several regulatory issues regarding licensing processes, oversight processes, and other issues.
