All radioactive waste has been decayed to background and disposed on 11/9/2017. The last date of service was 02/16/2017.

According to our regulations, the Cs-137 rod source is exempt from leak testing as it is less than 100 microcuries.

All sealed sources were disposed by Bionomics on 11/9/2017. The disposition record for the Co-57 source is attached.
