Dear Mr. Cash:

By letter dated September 25, 2017, Lost Creek ISR, LLC (Lost Creek) submitted to the U.S. Nuclear Regulatory Commission (NRC) responses to the NRC staff's request for additional information (RAI) on the KM horizon/Lost Creek East Amendment Application (NRC Agencywide Documents Access and Management System (ADAMS) Accession No. ML17275A669). A public meeting (webinar) was held between the NRC staff and Lost Creek's representatives to discuss perceived deficiencies and/or clarify aspects of several responses (ML17339A177). As discussed at that meeting, the responses for RAI-2, 8, 11, 15, 16 and 19 were administratively inadequate. It is NRC staff's understanding that Lost Creek understands the NRC staff's issues and is preparing a supplemental information.

With that in mind, NRC will delay finalizing the administrative completeness review of Lost Creek's responses until receipt of the supplemental information. Further, the NRC staff expects submittal of the supplemental information in the near future. Although no specific date was established, please provide a supplement information with 30 days of receipt of this letter.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
