SUBJECT: MEETING SUMMARY – CLARIFICATION CALL REGARDING VOLUNTARY REQUEST FOR INFORMATION ON COMPOSITE SEDIMENT SAMPLING FOR THE POHAKULOA TRAINING AREA (SOURCE MATERIALS LICENSE NO. SUC-1593, DOCKET NO. 040-09083)

Dear Dr. Cherry:

On December 4, 2017, the U.S. Nuclear Regulatory Commission (NRC) staff and the U.S. Army Installation Management Command (Army) had a clarification teleconference. The purpose of this meeting was for the staff to review with the Army, the voluntary request for information (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17297B403) on composite sediment sampling related to the Title 10 of the Code of *Federal Regulations* (10 CFR) 2.206 petition that the staff is currently reviewing regarding the Pohakuloa Training Area (ADAMS Accession No. ML17110A308).

The staff reviewed the questions with the Army and then asked whether the Army needed the staff to clarify any of the RAI questions for the Army's understanding. The Army said that it understood the RAI questions. The staff asked whether the Army would be able to respond to the voluntary request within 30-calendar days from the date of the letter. The Army said that it was planning on providing a response to the requested information by the end of December. The list of attendees participating in the teleconference are provided in the enclosure. No decisions were made during the teleconference. No new actions resulted from this teleconference.
