Dear Ms. Parr:

While performing their technical review of a request to renew special nuclear materials (SNM) license SNM-1107, transmitted by letter dated December 17, 2014, and revised by letter dated September 17, 2017, the staff at the U.S. Nuclear Regulatory Commission (NRC) have identified additional information that is needed before final action can be taken on your submittal. The enclosed request for additional information (RAI) pertains to the review of the application to renew license SNM-1107 and the environmental assessment associated with the renewal action.

The additional information, specified in the enclosure, should be provided within 30 days from the date of this letter. The NRC staff recognizes that the schedule date has changed from the anticipated completion date stated in letter dated May 10, 2017, due to challenges with the completeness of some of the previous RAI responses, and the need for additional clarification on those RAIs. The NRC will promptly communicate any changes to the schedule after receiving the additional information requested by this letter.
