**Re: Notice of Proposed Change of Ownership: Williamson Memorial Hospital, LLC  
(Radioactive Materials License #47-25358-01)**

Dear Mr. Gallagher:

I write on behalf of Williamson Memorial Hospital, LLC (the "Company"). The Company owns and operates Williamson Memorial Hospital, an acute care hospital located in Williamson, West Virginia (the "Hospital"). Pursuant to 10 C.F.R. § 30.34(b), the purpose of this letter is to provide notice to the United States Nuclear Regulatory Commission (the "NRC") of the anticipated change of ownership of the Hospital and to obtain the consent of the NRC to the transfer of control of the above-referenced radioactive materials license issued by the NRC. The Company is a party to a definitive agreement that, subject to the satisfaction or waiver of certain conditions, will result in the acquisition of substantially all of the assets and operations of the Hospital by Mountaineer Community Hospital, Inc., a West Virginia not for profit corporation (the "Proposed Transaction").

On September 1, 2017, we provided notice to the NRC of the anticipated change of ownership of the Hospital through a transaction in which Collaborative Healthcare Solutions, Inc. would acquire substantially all of the assets and operations of Seller, including the Hospital (the "Proposed Transaction"). On September 27, 2017, we provided notice to the NRC that the anticipated change of ownership would be effective November 1, 2017 and in addition, that Mountaineer Community Hospital, Inc. ("Buyer") would acquire substantially all of the assets and operations of Seller, including the Hospital—not Collaborative Healthcare Solutions, Inc. A copy of our prior correspondence is attached as **Exhibits A and B**.

The purpose of this letter is to provide notice that the parties now anticipate that the effective date of the Proposed Transaction will be **December 31, 2017**; however, the closing could take place at a later date depending upon the timing of regulatory and other necessary approvals.




