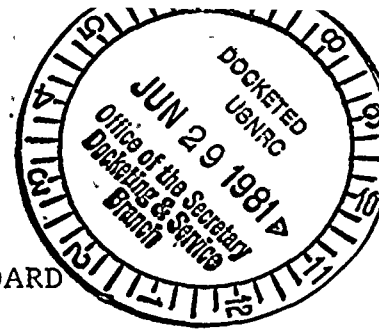


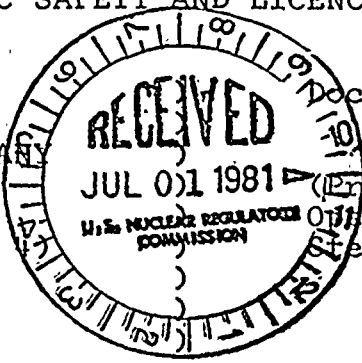

EXCEPTIONS TO FINAL ORDER.

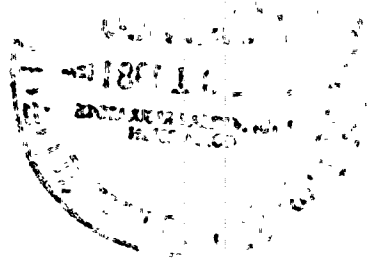
Intervenor, Mark P. Oncavage, files the following exceptions to the Final Order in this action dated June 19, 1981.

1. The Board erred in finding that the total quantity of radioactivity from waste that might be retained on site during repairs was 23.2 ci. First paragraph on Page 5 of the order.
2. The Board erred in finding that the protective measures suggested by the licensee make it extremely unlikely that the package would be breached during a hurricane or tornado. Second paragraph on Page 5 of the order.
3. The Board erred in finding that the disposition of low level solid waste from the steam generator repairs will be the same as the processing of such waste during normal operation. Third paragraph on Page 5 of the order.
4. The Board erred in finding that the impact of a hurricane or tornado on the low level waste produced by the steam generator repairs and stored on site will not pose a significant radiological hazard to the public. Second paragraph on Page 6 of the order.

5. The Board erred in ruling that each of the twelve (12) statements of position filed by the Intervenor were inappropriate. Third paragraph on Page 6 of the order.

6. The Board erred in ruling that the licensee need not submit to the Commission an application that sets forth its proposed disposal procedures for the low level waste stored on site. Position I on Page 6 and Position II on Page 7 of the order.

7. The Board erred in ruling that the storage of low level waste on site was not a major federal action. Position III on Page 7 of the order.

8. The Board erred in finding that the issue of the storage and disposition of low level solid waste was adequately addressed in the FES. Positions IV, V, and VI on Page 7 of the order.

9. The Board erred in ruling that it has no jurisdiction over disposition of low level waste not generated by the repairs which will interact with waste generated by the repairs. Position VII on Page 7 of the order.

10. The Board erred in ruling that the repair should not be delayed until the NRC completes its review of the disposal of low level solid waste. Position VIII on Page 7 of the order.

11. The Board erred in ruling that the licensee need not be required to determine that all solid waste sent for burial contain no detectable free liquids. Position IX on Page 7 of the order.

12. The Board erred in not rejecting the licensee application due to the fact that the licensee cannot lawfully dispose of its low level solid waste. Position X on Page 7 of the order.

13. The Board erred in not requiring the staff and licensee to examine the low level disposal capacity of Turkey Point. Position XI on Page 7 of the order.

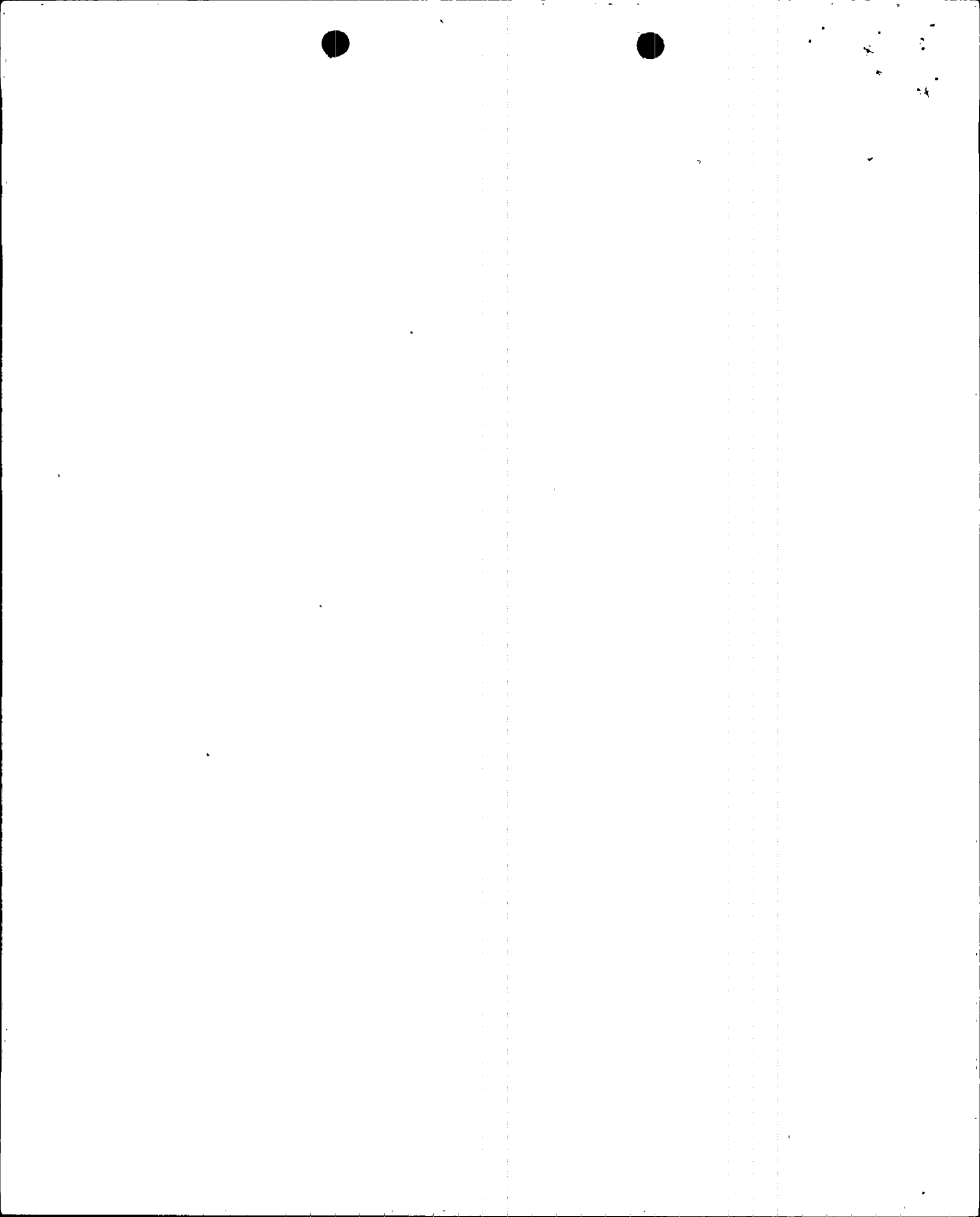
14. The Board erred in not permitting the Intervenor to reopen discovery. Position XII on Page 8 of the order.

15. The Board erred in authorizing the issuance of the license amendment to permit the proposed repairs at Turkey Point. Last paragraph on Page 8 of the order.

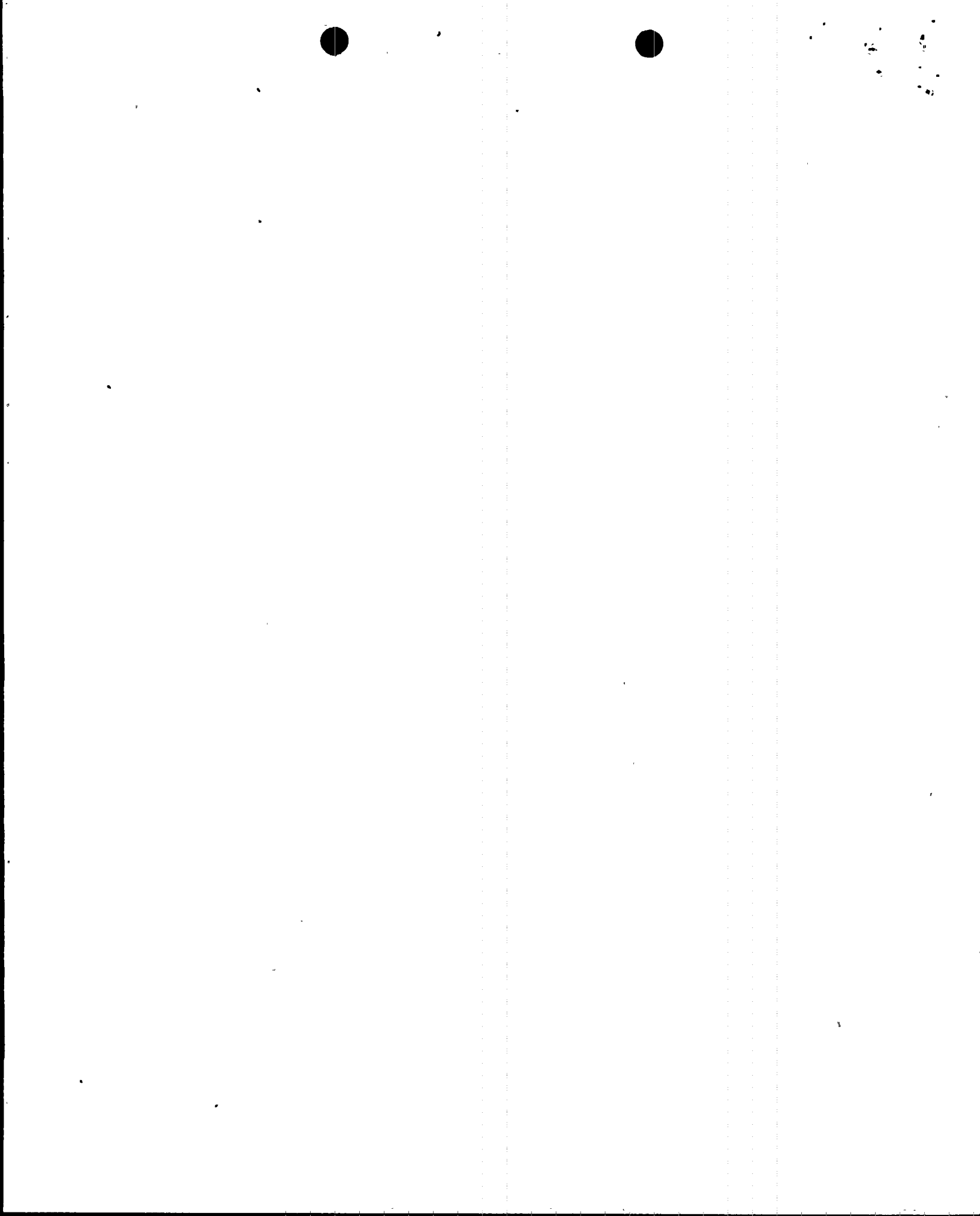
