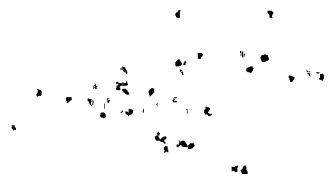

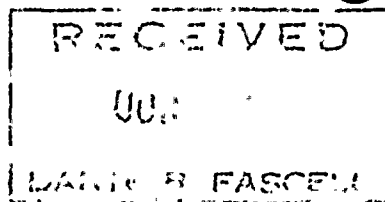
Dear Representative Fascell:
