

Re: Turkey Point Units 3 & 4 Docket No. 50-250 & 50-251 Proposed License Amendment Fuel Assembly Decay Period



In accordance with 10 CFR 50.30, Florida Power & Light Company submits herewith three signed originals and forty copies of a request to amend Appendix A of Facility Operating Licenses DPR-31 and DPR-41.

This amendment is submitted to allow up to 36 assemblies of the Unit 3 Region 10 fuel to be removed from the Unit 3 spent fuel pit after a decay period of 95 days instead of the presently required period of 120 days. These assemblies were in a critical reactor at very low power for only approximately 67 1/2 hours between April 19, 1981 and April 24, 1981 and are to be transferred to the Unit 4 spent fuel pit.

The proposed amendment is described below and shown on the accompanying Technical Specification pages bearing the date of this letter in the lower right hand corner.

Page 3.12-1

A footnote changing the decay period for Unit 3 from 120 days to 95 days is added.

We have determined that this is a Class I and Class III request in accordance with 10 CFR 170. A check for \$4,400 is enclosed.

The proposed amendment has been reviewed by the Turkey Point Plant Nuclear Safety Committee and the Florida Power & Light Company Nuclear Review Board.
