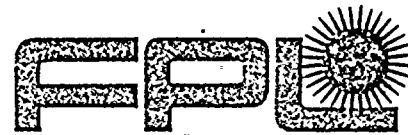

Our letter L-82-46, dated February 9, 1982 transmitted a similar request regarding the updating of our offsite organization. However, following discussions with your Staff we are now superceding that submittal in its entirety with the following proposed License amendment.

This amendment is intended to update our offsite management organization to reflect recent corporate change.






