Dear Ms. Lorion:

By letter dated April 10, 1986, you indicated that you are on the Turkey Point Plant service list and received a copy of our March 20, 1986, letter which transmitted draft reports on Probabilistic Risk Assessments (PRAs) to Florida Power and Light Company. You further stated that you did not receive a copy of the draft PRA reports. As you will note on your copy of the letter, all parties on the service list received a copy of the letter without the enclosures. The staff provided copies only to all of the licensees due to the limited number of the draft PRAs available at the time.
