Turkey Point Units 3 and 4 Re: Docket Nos. 50-250 and 50-251 **Proposed License Amendment** Organization and Event Reporting

On August 20, 1985 Florida Power and Light Company submitted a request to amend Appendix A of Facility Operating Licenses DPR-31 and 41 to reflect changes in the off-site organization and to revise event reporting in accordance with Generic Letter 83-43, which implements the reporting requirements of 10 CFR 50, Sections 50.72 and 50.73.

Subsequent to the submittal of that request, FPL made certain management changes which require changes to Figures 6.2-1 and 6.2-2, i.e., the addition of a Group Vice President for the engineering, project management, construction, power supply, system planning and fuel resources areas, and a Site Engineering Manager reporting to the Vice President Turkey Point Nuclear. The Group Vice President replaced the Power Plant Engineering Principal Engineer as a member of the Company Nuclear Review Board (CNRB). The composition of the CNRB (6.5.2.2, Page 6-9) is changed to reflect this.

In addition, the following other changes are required. Paragraph 6.9.3.g (page 6-18) of our August 20, 1985 submittal incorrectly referenced specification 3.9.1.d and 3.9.1.d.3. The correct references are 3.9.2.e and 3.9.2.e.2 Also, the reporting requirement for reactor coolant specific activity is reinstated, with the information now required for Specification 3.1.4.2 to be included in the Radioactive Effluent Release Report (6.9.4.a). That reporting requirement should not have been deleted. Generic Letter 85-19 stated that the reporting requirement related to specific activity could, however, be reduced from a short term to an annual requirement.

Pages 3.1-5, 6-9, 6-18, 6-21, 6-22, and 6-23, and Figures 6.2-1 and 6.2-2 reflecting the above changes are attached. They supersede those included with our August 20, 1985 submittal.

FPL considers these changes to be either administrative and/or editorial, and consistent with the intent of our August 20, 1985 request noted above. They have been reviewed by the Turkey Point Plant Nuclear Safety Committee and the FPL Company Nuclear Review Board.
