SUBJECT: REPORT NOS. 50-250/86-19 AND 50-251/86-19

On March 19-22, 1986, NRC inspected activities authorized by NRC Operating License Nos. DPR-31 and DPR-41 for your Turkey Point facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The inspection findings indicate that certain activities violated NRC requirements; however, as a result of the current NRC policy statement on training and qualification of nuclear power plant personnel, these items will be carried as unresolved pending further NRC evaluation.
