SUBJECT: NOTICE OF VIOLATION  
(NRC INSPECTION REPORT NOS. 50-250/87-08 AND 50-251/87-08)

This refers to the special team inspection of Environmental Qualification conducted by the NRC March 2-6, 1987, of activities authorized by Operating License Nos. DPR-31 and DPR-41 for the Turkey Point Nuclear plant. The results of this inspection were previously sent to you by our letter of July 21, 1987. The inspection team identified five deficiencies classified as Potential Enforcement/Unresolved Items. We have determined from a further review of these matters that four of the five Potential Enforcement/Unresolved Items constitute violations of NRC requirements. These four are identified in the inspection report as items: 50-251/87-08-02, "Raychem Splice Sleeves in Unqualified Configurations"; 50-250, 251/87-08-03, "Unqualified Texaco Marfak Grease"; 50-250, 251/87-08-04, "3M Tape Similarity"; and 50-250, 251/87-08-05, "3M Tape Level of Qualification." The violations, references to pertinent requirements, and elements to be included in your response are presented in the enclosed Notice of Violation.

Potential Enforcement/Unresolved Item 50-250, 251/87-08-01, "Lack of Cable Traceability" is still regarded as an Unresolved Item.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and its enclosures will be placed in the NRC Public Document Room.

The responses directed by this letter and its enclosure are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96-511.
