

This letter is to advise you of our schedule to complete the items which were identified as incomplete in the NRC Post Implementation Audit Report dated 10/27/88.

1) NUREG 0737, Supplement 1 requirement for a continuous display of plant safety status information.

This issue has been addressed and is considered complete at this time.

2) NUREG 0737, Supplement 1 requirement for a reliable SPDS.

This issue has been addressed and is considered complete at this time.

3) NUREG 0737, Supplement 1 requirement for incorporating human factors engineering principles.

This issue will be resolved by:

- a) The Nuclear Engineering department (JPN) will arrange an independent contractor to audit the existing system. This audit is scheduled for completion by January 31, 1989.
- b) Turkey Point will implement the recommended corrective actions by July 31, 1989.
- 4) NUREG 0737, Supplement 1 requirement for operator training with and without SPDS.

Training of licensed operators, except for operators who are on vacation or otherwise unable to attend, will be completed prior to restart from the current Unit 4 refueling outage. Training of operators who were not trained prior to Unit 4 restart will be completed prior to the operators assuming a shift position.

If a schedule change is required due to unforeseen circumstances, the revised schedule will be forwarded to you in advance of the commitment date.
