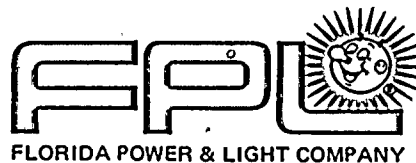

In your December 13, 1982 letter, subject matter Environmental Qualification of Safety Related Electrical Equipment, you requested certain information about plans and schedules for accomplishing our proposed corrective actions within 90 days of the receipt of your letter. Subsequent to that letter the final rule 10 CFR 50.49 was issued which requires similar information be submitted on a different schedule. After discussion with your staff it was agreed that the schedule required by the rule was applicable, and FPL would work to the schedule in the rule.
