Subject: Removing Suite 102 as a location of use

In my email request for additional information on October 25, 2017, I asked Mr. Norweck to confirm that Room 125 was the only area within Suite 102 that was used for radioactive material, and that it was acceptable to remove all of Suite 102 from the license. He did confirm that only Room 125 was used and that it was acceptable to remove Suite 102. I also reviewed documentation in the docket file, and confirmed that during the last license renewal, only Room 125 was requested for use. Also, at that time, closeout surveys were submitted for Room 121 in Suite 102. Room 121 in Suite 102 was released for unrestricted use in license renewal letter dated October 21, 2011. I also confirmed with Mr. Norweck that all equipment was in calibration for the closeout surveys submitted to release Room 125. I can release Suite 102 for unrestricted use.
