By letters dated October 27, 1982, March 3, 1983, March 3, 1984 and April 2, 1984, you have provided your Inservice Test (IST) Programs, Inservice Inspection (ISIT) Programs and associated Technical Specification changes for the second 10 year interval for Turkey Point Plant, Units 3 and 4.

The submittals for the ISI and Technical Specification changes include recent revisions to code boundry drawings and Technical Specifications to ensure compliance with 10 CFR 50.55a. The staff is reviewing your submittals on a basis consistant with the need for approval prior to the next refueling outage when the new programs will be needed. The staff has also received additional information on the first program and is assessing its adequacy.

We have received the information necessary for our review for the above programs to assess their adequacy prior to their need. We will inform you if additional information is needed.


