### FUNCTIONAL STATEMENT

As Branch Chief, manages the Intelligence Liaison and Threat Assessment Branch and in the analysis and evaluation of domestic and foreign events and incidents to detect patterns and trends and provide a basis for regulatory change and incident response. Directs the assessment of the threat environment affecting SG nuclear facilities and activities.

### REGULAR DUTIES

Plans, coordinates and manages NRC's response activities dealing with Safeguards events during transportation and at non-reactor facilities. Represents NRC in liaison with other Federal and State agencies for exchange of threat related information, resource support and negotiating formal interagency agreements for incident response support.

Functions as Branch Chief, Intelligence Liaison and Threat Assessment Branch, Division of Security Operations, NSIR.

Develops and recommends goals and courses of action applicable to safeguards operational data assessments and identifies requirements for the improvements of safeguards systems and regulatory policy and programs as a result of assessments.

Directs analyses of events or trends from the operational data base to provide feedback to the Regions and licensees for improved Safeguards operations.

Represents NRC in liaison with other Federal and State government agencies (CIA, FBI, DOE, etc.) regarding the exchange of threat related information, incident response, and revision/implementation of formal interagency agreements.

Directs the branch staff in identifying interface needs and in developing a working exchange with key personnel from other Federal and State government agencies to facilitate information exchange and resource support for coordinated responses to threats or incidents. Directs the preparation of formal requirements letters as necessary to the agencies concerned for the Director, NSIR.



**Directs the analysis and assessment of threat information to determine credibility and degree of seriousness. As a member of the Information Assessment Team, provides assessment to NRC senior management for information or recommended action.**

Interfaces with applicable Federal and State government agencies, NRC Regional offices, laboratories, industry and media regarding threat related information and to provide on-going analysis of information to determine the characteristics, capabilities and trends of the current and developing threat; assesses information on proliferation, concerns research and developing technology in support of NSIR Safeguards incident response, threat environment, and event analysis activities. Coordinates with other NRC offices as appropriate and reports results to cognizant senior management.

Responsible for analysis and assessment of threat environment in foreign countries in support of U. S. Nuclear Export Licensing.

Directs the preparation, publication and subsequent revisions of the Safeguards Summary Event List (NUREG-0525) semi-annually which provides a trend analysis of domestic nuclear-related events of Safeguards significance.

Directs the development and publication of Foreign Safeguards Summary Events List of foreign nuclear related events of Safeguards significance.

Responsible for developing and implementing Safeguards incident response plans and procedures and for the scheduling and execution of training exercises for the Safeguards Incident Response Team.

Develops and recommends studies and programs to achieve more effective threat assessment systems which provide a basis for safeguards policy, regulations and guides.

Responsible for identifying and directing threat, event, and incident response related studies. In this capacity provides technical guidance, requests input from other agencies, NRC offices and Regions, laboratories, coordinates, integrates and evaluates input and results to meet studies objectives. Studies include development and maintenance of support data bases for threat assessment, event analysis, and incident response; analysis of threat environment, published semi-annually as Threat Environment Review; joint FBI/DOE/NRC Threat Credibility Assessment; jointly supported NRC and DOE in-service training programs for the FBI.

Presents briefings to other Federal and State agencies, other NRC offices, and industry representatives on threat assessment, inter-agency responsibilities, and incident response planning and implementation.

Responsible for all Branch technical support contracts. Directs the identification of contract support requirements, statements of work and evaluation criteria. Monitors contractor performance to provide guidance and direction as necessary.

#### OCCASIONAL DUTIES

Serves as Acting Deputy Director when designated.

Assists in planning and participating in NRC seminars with licensees and other Federal and State government agencies concerning threat assessment and incident response.

Provides direct support to the Division Director on safeguards policy as a result of operational data assessment.

#### BASIC SKILLS

Detailed and comprehensive knowledge of intelligence organizations, roles and capabilities. Competence must be of a degree to enable independent evaluation of the safeguards significance, source credibility and validity of information for safeguards purposes.

Knowledge of theories and concepts related to systems analysis/systems engineering sufficient to direct and evaluate projects associated with the development and implementation of threat assessment and incident response systems.

Ability to identify and direct the performance of the exceptionally complex studies required in support of safeguards contingency planning from the aspects of threat assessment, interagency liaison, and incident response. Ability to define the objectives, scope, content and approach of required studies which provide a basis for safeguards policy, planning and rulemaking.

Advanced skill in the administration and direction of technical contracts in order to obtain desired objectives. Demonstrated ability in the preparation and presentation of briefings concerning contingency planning, threat assessment and event analysis to other government agencies, NRC offices and regional representatives.

Complete knowledge of NRC's safeguards programs, regulatory process, and atomic energy legislation to effectively direct the branch activities.

Demonstrated skill in task priority determination and the ability for expeditious, meaningful response to exceptionally complex, sensitive action items.

Demonstrated ability in exercising tact and diplomacy in successfully establishing and maintaining high level sensitive interfaces for information exchange and mutual support between NRC and other agencies. Ability to effectively negotiate Interagency Agreements with other Federal agencies and skill to sufficiently recognize relative merits and potential impact of various negotiated concessions within proposed agreements.

Ability to identify pertinent items whose threat significance merits the attention of NRC senior safeguards management and to prepare appropriate conclusions and recommend actions for consideration by management, up to and including the Commission, and cognizant Federal agencies.

Sophisticated analytical ability to make definitive and authoritative evaluations and effectively present technical results of individual studies and contracts. Advanced executive writing skills required for preparation of Commission papers and other high-level, exceptionally complex documentation.

Ability to correlate and corroborate intelligence information from diverse sources and direct and evaluate the analysis and assessment of such information to determine its credibility and seriousness in regard to potential impact on the nuclear industry.

#### CONTACTS

Frequent contact with the Office Director to provide information and/or recommendations concerning Information Assessment Team.

Frequent contact with program directors and managers of other Federal and State government agencies to exchange information and develop resource support for coordinated agency response to threats or incidents. Frequent contact with program directors and managers of other Federal government agencies for the development and implementation of interagency agreements.

Frequent communication with NRC Division officials and other Federal government agency officials at the Director, Deputy Director and Branch Chief levels to resolve problems in operational data assessment.

Frequent contact with Office and Division Directors and other agency officials to recommend improvements in SG systems and changes in regulatory policy and programs as a result of studies and assessments.

Frequent contact with NRC Directors and managers, up to and including the Commission level, Regional representatives, other Federal and State government officials and industry representatives to present briefings on SG threat and incident response policy, analysis and interpretation of evaluation results.

Occasional contact with academic and technical personnel in the private sector to maintain the branch's proficiency in state-of-the-art analysis as related to threat and event analysis and evaluation.

Occasional contact with Congressional and executive department staff to explain technical aspects of ongoing studies, reports and plans as related to the threat environment.

#### RESPONSIBILITY FOR DECISIONS

##### Supervision Received

General Supervision "A".

Administrative guidance is indicated in overall NRC policy. Operational guidance is generally received by oral instructions or action items with specific due dates.

##### Independent Action

Explores need for and establishes working liaison with multiple Federal agencies.

Identifies and recommends to Office Director studies in support of safeguards incident response from the aspects of interagency liaison and crisis management; conducts and implements joint studies with other Federal agencies and other NRC offices, as independent contract support efforts or in-house projects.

Recommends to Office Director overall policy and goals for the NRC threat assessment and interagency liaison program.

#### RESPONSIBILITY FOR DECISIONS

##### Independent Action

Recommends to Office Director alternative courses of action in response to the assessment of threat and safeguards events.

Recommends to Office Director requirements for interagency agreements in relation to threat assessment and intelligence information requirements.

Provides technical supervision to branch personnel in the accomplishment of assigned projects.

Negotiates interagency safeguards agreements with program directors of other Federal agencies. Makes on the spot determinations of the relative merits and potential impact of various items within the proposed agreements.

Presents briefings to other Federal agencies, industry representatives, NRC offices, and NRC Regional representatives on threat assessment, safeguards incident response, interagency agreements, and intelligence information aspects of contingency planning.

Approves branch administration matters.
