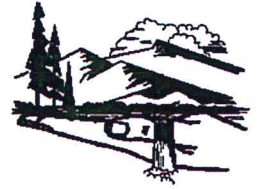

The Wyoming Department of Environmental Quality – Land Quality Division (WDEQ/LQD) District 2 Office received Lost Creek ISR's (LCI) Notice of Completion of Construction for Class 3 wells in Mine Unit 2 Header House 3 (HH 2-3) on October 12, 2017. The above referenced Notice included the certification records for 69 wells in HH 2-3. The records submitted included Well Casing Records, Well Completion Reports, and MIT Reports as well as Digital Well Logs. A review of this submission was performed in lieu of an onsite records review for the HH 2-3 Notice and WDEQ/LQD will not exercise its right to inspect these wells as provided for in Chapter 11, Section 11(b)(ii)(A) and (B).

**All well certifications indicated in the above-referenced Notice are hereby accepted by the WDEQ/LQD as being in compliance with the approved Operations Plan and LQD Noncoal Rules and Regulations Chapter 11, Section 11(b).**

Lost Creek ISR is authorized to commence ISR injection and mining operations using the 69 wells described in the Well Completion Summary Report submitted under a cover letter dated October 12, 2017 within HH 2-3 in accordance with the Operations Plan for Permit 788.
