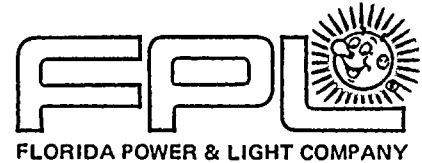

By our letter dated December 12, 1986 (L-86-488) FPL provided the results of a spiked sample in accordance with the Confirmatory Measurement Program.

It has been determined that the SR-89/90 and Fe-55 values reported to you in our November 26 correspondence were incorrect. After applying the correct aliquot factor, the revised values are as follows:

Sr-89	3.6	E-05	$\mu\text{Ci/ml}$
Sr-90	2.68	E-06	$\mu\text{Ci/ml}$
Fe-55	1.15	E-05	$\mu\text{Ci/ml}$

The tritium value remains as originally reported.
