This refers to your license amendment request dated October 6, 2017. Please find enclosed Amendment No. 5 removing Suite 102 as a location of use. It was noted that Room 125 in Suite 102 was the only room currently licensed for radioactive materials use, and that Room 121 in Suite 102 had previously been released for unrestricted use in license renewal letter dated October 21, 2011. Suite 102 may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. 
