Security Organization Changes

Several organizational changes have been recently implemented that affect Florida Power & Light Company's (FPL) administration of the security programs for its nuclear facilities. In response to a recent request for details made by members of your staff, the following brief description of these changes is being provided.

FPL letter L-88-216, dated May 13, 1988 describes the reorganization of the senior nuclear management positions. This change created the positions of Senior Vice President-Nuclear and Vice President - Nuclear Energy. This organization is further defined in the Topical Quality Assurance Report and has been included in Revision 14 to the Turkey Point Physical Security Plan.

As a part of the current plan to bring departments that support the nuclear facilities under the direct control of the nuclear management of FPL, the Nuclear Security Section has been established in the organization of the Vice President - Nuclear Energy. They are responsible for the security aspects of our nuclear facilities. Specifically they will direct the overall development and implementation of the nuclear security policy. They will coordinate and perform many of the nuclear security related functions that

had been previously performed outside of the direct management control of the Nuclear Energy Department. This group will be responsible for the maintenance of all security related plans for both the Turkey Point and St. Lucie facilities and will coordinate any revision or updates to these plans with the sites. This new group will also assume the responsibility for administration of the security guard force contract. Additionally, the Nuclear Security Section will be responsible for the implementation of the security aspects of the emergency/recovery plan. Corporate Security Services will retain the responsibility for the law enforcement liaison activities except those expressly required by the individual plant security plans. These activities will remain under the control of the Plant Security Departments.

Changes have also been made in the organization of the Turkey Point Security Department to enhance its overall effectiveness. A new Plant Security Supervisor has been hired from outside FPL who is responsible for the implementation of the security plan and management of the day-to-day security activities. Several new positions have been established to support the Plant Security Supervisor in this effort and to ensure he is not over burdened by the management aspects of the extensive security upgrade program. As described in Revision 14 to the Turkey Point Physical Security Plan issued June 23, 1988, five Plant Security Specialist positions have been established to provide the onshift direct observation and monitoring of activities performed by the contractor security force. Currently four of these positions are filled and interviews are being conducted to fill the remaining position. The Plant Security Specialists report to a Plant Security Coordinator who reports to the Plant Security Supervisor.

Under the reorganization, the responsibility for the coordination and interface activities of the security upgrades has been transferred to the new temporary position of Plant Security Project Manager. This position has been established to provide a management overview of the activities surrounding the security system upgrade tasks currently identified in the integrated schedule.

The Plant Security Supervisor and the Plant Security Project Manager report to the Site Services Manager who reports to the Site Vice President.



Appropriate changes to the physical security plans, the training and qualification plans, and the safeguards contingency plans for St. Lucie and Turkey Point Plants are currently under revision. It is anticipated that the revised plans to include these organization changes will be issued by August 31, 1988.

It is felt that the above described organizational changes will facilitate better management oversight and accountability for the security of our nuclear facilities by placing them under the control of the Nuclear Energy Department.
