By letter dated May 26, 1989 (Luis A. Reyes to C. O. Woody), NRC confirmed the dates of July 10 - 14, 1989, for a special Appendix R inspection of Turkey Point. In addition, the letter requested Appendix R information be provided to NRC Region II Staff by June 9, 1989.

During a telephone conversation on June 6, 1989, between Mr. T. Conlon of Region II staff and Messrs. R. Gritz and J. Kirk from Florida Power and Light, new dates were established for the inspection and the submittal of the requested information.

This letter is provided to confirm the dates of August 21 - 25, 1989, for the special inspection of Turkey Point Units 3 and 4 regarding sections III.G, III.J, and III.O, of Appendix R to 10 CFR 50. 
