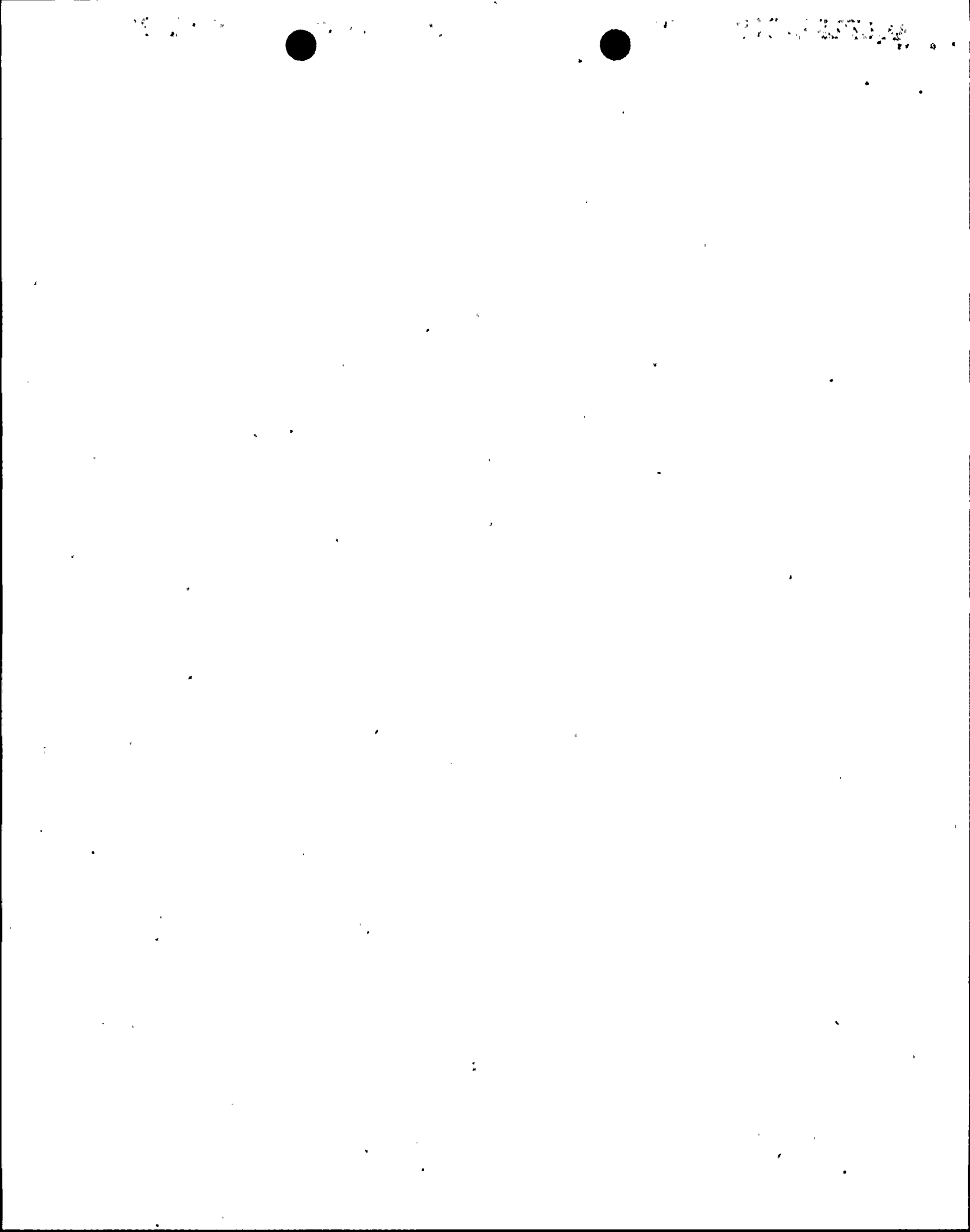

Generic Letter 89-06

Generic Letter (GL) 89-06, "Task Action Plan Item I.D.2., Safety Parameter Display System", dated April 12, 1989, requested that licensees provide certification of the status of implementation of the safety parameter display system (SPDS) at their facilities.

By letter dated October 27, 1988, the NRC issued its Post Implementation Audit Report for the Turkey Point Units 3 and 4 SPDS. The audit was conducted March 23 through March 25, 1987. The purpose of the audit was to ascertain whether the SPDS met the minimum requirements of NUREG-0737, Supplement 1, whether it has been installed in accordance with FPL's implementation plan (previously approved by the NRC Staff), and whether it was functioning properly. That report identified open items with respect to four of the NUREG-0737, Supplement 1 requirements, and requested that FPL provide its schedule for completing the necessary actions to resolve these open items.

By letter L-88-520, dated December 7, 1988, FPL provided a schedule for completion of action on the SPDS open items identified in the NRC Post Implementation Audit Report.

Currently, the only actions remaining to be completed are those pertaining to the NUREG-0737, Supplement 1 requirement for incorporating human factors engineering principles. An independent human factors evaluation of the Turkey Point SPDS was recently completed with a final report being issued to the plant on June 28, 1989. The human engineering discrepancies (HEDs) identified during the review are currently being evaluated. A schedule for their resolution will be provided to you by August 31, 1989.

As required by the generic letter, FPL certifies that the SPDS will be modified to fully meet the requirements of NUREG-0737, Supplement 1. FPL will take into account the information provided in NUREG-1342 as requested by the generic letter, but our certification is limited to NUREG-0737, Supplement 1 requirements.

GL 89-06 requested that a response be submitted within 90 days of the date of the letter (April 12, 1989). FPL received it on May 15, 1989. Because of its late receipt, FPL requested an extension of the submittal date to 90 days from date of receipt. That request was granted by Dr. Gordon Edison, the NRC Project Manager for the Turkey Point Plant.
