**List of Approved Spent Fuel Storage Casks: TN Americas, LLC; Standardized NUHOMS® Horizontal Modular Storage System; Certificate of Compliance No. 1004; Renewal of Initial Certificate and Amendment Nos. 1 Through 11 and 13, and Revision 1 and 14; Direct Final Rule; Confirmation of Effective Date; Part 72 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AK05; NRC-2017-0138)**

On December 8, 2017, the NRC published a document in the *Federal Register* ([82 FR 57819](#)) confirming the effective date of December 11, 2017, for the direct final rule that was published in the *Federal Register* on September 27, 2017 ([82 FR 44879](#)). This direct final rule amended the NRC's spent fuel storage regulations by revising the Standardized NUHOMS® Horizontal Modular Storage System listing within the "List of approved spent fuel storage casks" to renew, for an additional 40-year period, the initial certificate and Amendment Nos. 1 through 11 and 13, Revision 1, and Amendment No. 14 of Certificate of Compliance (CoC) No. 1004. These changes require that all future amendments and revisions to this CoC include evaluations of the impacts to aging management activities (i.e., time-limited aging analyses and aging management programs to ensure that they remain adequate to timely identify any changes to spent fuel storage cask systems, structures, and components within the scope of the renewal.
