TVA requests a clarification call on the following information needs associated with Terrestrial Ecology:

1. Information need TE-02 requests additional information that is very similar in nature to Supplemental Information provided in CNL-16-200, "Submittal of Supplemental Information Regarding Terrestrial Ecology in Support of Early Site Permit Application for Clinch River Nuclear Site," dated December 13, 2016. Is information need TE-02 in addition to what has been provided in CNL-16-200?
2. Information need TE-07 requests additional information that is very similar in nature to Supplemental Information provided in CNL-16-200, "Submittal of Supplemental Information Regarding Terrestrial Ecology in Support of Early Site Permit Application for Clinch River Nuclear Site," dated December 13, 2016. Is information need TE-07 in addition to what has been provided in CNL-16-200?

3. Information need TE-08 requests additional information that is very similar in nature to Supplemental Information provided in CNL-16-201, "Submittal of Supplemental Information Regarding Aquatic Ecology in Support of Early Site Permit Application for Clinch River Nuclear Site," dated December 16, 2016. Is information need TE-08 in addition to what has been provided in CNL-16-201?
4. Information need TE-10 refers to identifying specifics in addressing best management practices in the ESPA. TVA has previously provided Supplemental Information provided in CNL-16-200, "Submittal of Supplemental Information Regarding Terrestrial Ecology in Support of Early Site Permit Application for Clinch River Nuclear Site' dated December 13, 2016" and in CNL-16-200, "Submittal of Supplemental Information Regarding Aquatic Ecology in Support of Early Site Permit Application for Clinch River Nuclear Site," dated December 16, 2016, that provides additional details addressing best management practices. Is information need TE-10 in addition to what has been provided in CNL-16-200/201?
5. Information need TE-16 refers to a storm water pollution prevention plan. TVA requests clarification on the specific requirements to have a Storm Water Pollution Prevention Plan as part of the ESPA.
6. Information need TE-20 is very similar in content to information need AE-04. TVA recommends the verification of information needs requested and deleting one of the duplicate information needs.
7. Information need TE-23 requests a discussion on how the Terrestrial Ecology criteria fit into the site selection process. Does this discussion include the Site Selection Report and/or section 9.3 of the ER?
8. Information need TE-24 is very similar in content to information need TE-09. TVA recommends the verification of information needs requested and deleting one of the duplicate information needs.
