SUBJECT: NRC INSPECTION REPORT NOS. 50-250/90-21 AND 50-251/90-21

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by A. Tillman on June 25-29, 1990. The inspection included a review of activities authorized for your Turkey Point facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed Inspection Report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Within the scope of the inspection, violations or deviations were not identified.

In accordance with 10 CFR 2.790(d) and 10 CFR 73.21, safeguards activities and security measures are exempt from public disclosure.
